The regular meeting was called to order after the Workshop ended at 7:15 pm in the Board Room of the Village Office. Roll Call was taken:

APPROVAL OF THE AGENDA

Agenda: Chairman Slama requested a motion to approve the agenda. Trustee Whitmore requested that the agenda be changed to put 6c, BFA Creek Restoration Overview, as the first item of business under Report of Committees, Commissions, and Contractors. Trustee Whitmore made a motion to approve the agenda with changes seconded by Trustee Fortune and motion passed with the unanimous consent of the Board of those present.

APPROVAL OF THE CONSENT AGENDA

Consent Agenda: Chairman Slama requested a motion to approve the Consent Agenda. BFA Creek Restoration Overview: Wes Theissen gave a presentation explaining the details of the Creek Restoration project. Discussion ensued. Trustee Whitmore motioned to approve Bill No. 498 as submitted, seconded by Trustee Eisenhauer and the motion passed 5-0 as follows: Trustee Eisenhauer-yea, Trustee Slama-yea, Graves-yea, Fortune-yea, and Whitmore-yea. SPECIAL DISCUSSION

Village Hall: Trustee Fortune updated the Board regarding the meeting he and Administrator Runge had with Greg Garner, the village's architect, earlier in the month. He stated that he felt he laid the ground rules for going forward. He told the Board that during the meeting, the option of limiting the community center from 80 persons to 60 and eliminating the extra workstations was discussed. He said that this would reduce the building by 400-500 square feet. He said that Greg should have a new floor plan for him to review within the next few days.

Attorney's Report: Attorney Rost stated that an addendum, related to SB5, needed to be filled out and returned by all cities, villages, etc. if they had a court or not. He stated he would be sending this information to Administrator Runge.
