# MINUTES OF REGULAR MEETING OF THE BOARD OF TRUSTEES TWIN OAKS, ST. LOUIS COUNTY, MISSOURI WEDNESDAY, JULY 01, 2015

The meeting was called to order at 7:08 pm in the Board Room of the Village Office. Roll Call was taken:

### **APPROVAL OF THE AGENDA**

Chairman Slama requested that item d) BFA Stormwater Study/Autumn Leaf Dr. be added under New Business. Trustee Fortune stated he would be reporting for Connie Fortune, Park Chair, under item 6b. Chairman Slama requested a motion to approve the agenda. Trustee Whitmore motioned to approve the agenda as amended, seconded by Trustee Graves and motion passed with the unanimous consent of the Board of those present.

### APPROVAL OF THE CONSENT AGENDA

Consent Agenda: Chairman Slama requested a motion to approve the consent agenda. Meeting Minutes of June 17: Trustee Whitmore motioned to approve the Meeting Minutes of June 17, 2015 as submitted, seconded by Trustee Graves and motion passed with the unanimous consent of the Board of those present. Trustee Fortune abstained.

**Special Meeting Minutes of June 23:** Trustee Graves motioned to approve the Special Meeting Minutes of June 23, 2015 as submitted, seconded by Trustee Fortune and motion passed with the unanimous consent of the Board of those present.

Bills List: Trustee Fortune motioned to approve the Bill Payment List from June 18 to July 1, 2015 as submitted, seconded by Trustee Eisenhauer and motion passed with the unanimous consent of the Board of those present. Trustee Slama abstained.

### REPORT OF COMMITTEES/COMMISSIONS/CONTRACTORS

Police Report: Office Mike Maxwell provided the June 2015 reports for the Board's review. There were no comments made. Officer Maxwell stated that there will be 4 additional Officers at the July 3<sup>rd</sup> event, besides himself. One will be at the Old Schnucks parking lot, one at the new Schnucks lot, one in the park and one at the entrance of the park. Officer Maxwell stated he will be on his bike and one other Officer will be on a bike.

The Board discussed that the Park will be closed and gates will be locked on Friday, July 3<sup>rd</sup> until 5:00 pm for safety issues. Chairman Slama stated that if anyone would like to help set up they will be starting at 8:00 am.

Park Report: Park Chair, Connie Fortune, was not in attendance but Board Liaison, Trustee Fortune reported the following:

- Chairman Slama attended the Park Committee Meeting to review the changes to the Park Regulations and stressed to the Committee that they need to discuss the various projects that they would like completed in the Park for next year's budget.
- Completed coordination for the July 3<sup>rd</sup> Fireworks Event.
- Discussed Family Fun Day
- Approved Autumn Leaf Entrance Gate plantings not to exceed \$2,000 that John, Maintenance, proposed to the Committee. Stated this would not be completed until the fall of this year.
- Advised that three split rail fences had been installed.
- Approved an extra bench be installed at the Autumn Leaf Entrance Gate
- Rose Garden mulching was completed
- Plantings by the Basketball Court will be removed

### **NEW BUSINESS**

Bill No. 478 - An Ordinance Approving Selection of Extreme Pyrotechnics, LLC as Display Operator for the 2016 Village Fireworks Display, Authorizing Notice of Intent to Award and Execution of Negotiated Contract: First reading of Bill No. 478 was read. Trustee Whitmore stated he felt that approving the vendor for the 2016 fireworks seemed pre-mature since the Board has not received the public reactions on this year's event. No further discussion ensued. Second reading of Bill No. 478 was read. Trustee Eisenhauer motioned to approve Bill No. 478 as submitted, seconded by Trustee Graves and the motion passed 5-0 as follows: Trustees Fortune-yea, Slama-yea, Eisenhauer-yea, Whitmore-yea and Graves-yea. Chairman Slama stated that Bill No. 478 being duly passed on July 1, 2015 now becomes Ordinance No. 460.

Bill No. 480 - An Ordinance Amending, Chapter 110: Administration, Section 110.040 of the Municipal Code of the Village of Twin Oaks: First reading of Bill No. 480 was read. No discussion ensued. Second reading of Bill No. 480 was read. Trustee Whitmore motioned to approve Bill No. 480 as submitted, seconded by Trustee Fortune and the motion passed 5-0 as follows: Trustees Eisenhauer-yea, Slama-yea, Graves-vea, Fortune-yea, and Whitmore-yea. Chairman Slama stated that Bill No. 480 being duly passed on July 1, 2015 now becomes Ordinance No. 461.

Bill No. 481 - An Ordinance Authorizing the Chairman of the Board of the Village of Twin Oaks, Missouri, to Execute the Municipal Housing and Community Development Cooperation Agreement of 2015-2017; and Supplemental Agreements Thereto With St. Louis County With Regard to the Housing and Community Development Act of 1974, as Amended: First reading of Bill No. 481 was read. Chairman Slama stated that a resident requested that the Village apply for the CDBG Funds (Community Development Block Grant). Village Clerk Runge gave a synopsis of the program and discussion ensued. Second reading of Bill No. 481 was read. Trustee Graves motioned to approve Bill No. 481 as submitted, seconded by Trustee Eisenhauer and the motion passed 5-0 as follows: Trustees Slama-yea, Graves-yea, Whitmore-yea, Fortuneyea, and Eisenhauer-yea. Chairman Slama stated that Bill No. 481 being duly passed on July 1, 2015 now becomes Ordinance No. 462.

**BFA Study/Autumn Leaf Dr.:** The Board discussed having BFA do a stormwater study extending the pipe up-stream from 1442 to 1418 Autumn Leaf Dr. Trustee Whitmore motioned to authorize BFA to extend the scope to include 1442, 1436, 1430, 1424 and 1418 Autumn Leaf Dr., seconded by Trustee Eisenhauer and motion passed with the unanimous consent of the Board of those present. The Board requested that each resident be notified that a study was being done. A meeting will be held for all parties involved upon completion.

### SPECIAL DISCUSSION

Chairman and Trustee Comments: No comments made.

### **CITIZEN COMMENTS**

Residents of 1442 and 1430 Autumn Leaf Dr. were in attendance. Both residents stated they feel part of their water run-off is coming from the top of the hill of the church property. They also stated that the church fence is falling down. Resident of 1442 Autumn Leaf Dr. stated he feels that a retaining wall with a fence would help address the issue. Discussion ensued. The Board requested Village Clerk Runge to discuss this issue with Ray Frankenberg, BFA, while researching the stormwater scope on Autumn Leaf Dr.

The Board requested to place the Stormwater Study that was completed in 2007 on the website for the residents to review.

There being no further business, Trustee Whitmore motioned to adjourn the regular meeting at 7:50 p.m., seconded by Trustee Graves and the motion passed with the unanimous consent of the Board of those present.
