## RESOLUTION No. 2017-07

A RESOLUTION OF THE TWIN OAKS BOARD OF ALDERMEN APPROVING A NEW NUMBERING SYSTEM FOR RESOLUTIONS AND RENUMBERING RESOLUTIONS 17-01 THROUGH 17-04 ACCORDINGLY.

WHEREAS, after it became a city of the fourth class, the Board of Aldermen of City of Twin Oaks, Missouri (the "Board") began to number its resolutions using a numbering system that referenced the two-digit year and number of the resolution for that year;

WHEREAS, the Board also used the same numbering sequence for ordinances; and

WHEREAS, during and after codification, references to such identical numbering systems for ordinances and resolutions can sometimes cause confusion; and

WHEREAS, to facilitate a system less likely to cause confusion, the Board desires to change its recently adopted numbering system for Resolutions;

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF TWIN OAKS, MISSOURI, AS FOLLOWS:

Section 1. The Board of Aldermen hereby approves the following numbering system for resolutions of the Board: 20XX-XX, where the first four digits represent the year and the last two digits represent the sequential number of the resolution for that year. Thereafter, the first four digits will change on January 1<sup>st</sup> of every year to represent the current year and the last two digits will reset to "01" at the beginning of the new year.

Section 2. The previously passed Resolutions for 2017 are renumbered as follows:
