Dennis L. Whitmore



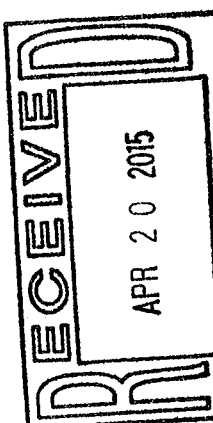
