WHEREAS, the Board of Aldermen wishes to accept the Election Results;



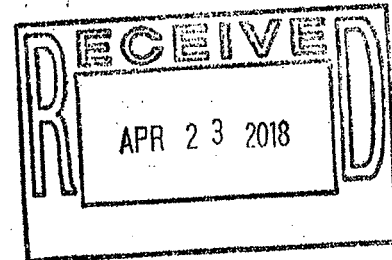
