

A RESOLUTION APPROVING CHANGE ORDER NO. 1 FOR THE CURB PAINTING PROJECT, INTERSECTION OF MO-141 AND BIG BEND ROAD, AND AUTHORIZING THE MAYOR TO EXECUTE SAME.

Whereas, the City of Twin Oaks (the "City") entered into an agreement with St. John Painting Corporation ("Contractor") effective August 1, 2018 for the painting of the City curbs at or near the Intersection of MO-141 and Big Bend Road and related services for a sum of not to exceed \$4,950.00 (the "Agreement"); and,

Whereas, the City and Contractor have identified further painting at the intersection that was previously not permitted by the Missouri Department of Transportation (MODOT), but which MODOT will now issue a permit to the Contractor to undertake, and which change will add \$2,800.00 to the Agreement; and,


Whereas, the City and Contractor further seek to add a contingent item of additional traffic control services to the Agreement for an additional cost of \$1,500.00 but which will only be charged if required under Contractor's permit from MODOT;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF TWIN OAKS, MISSOURI, AS FOLLOWS:

Section 1. The Board of Aldermen hereby approves Change Order #1, attached hereto as Exhibit A and incorporated herein by reference.


Section 2. The Board of Aldermen further authorizes the Mayor to execute Change Order #1 substantially in the form of Exhibit A.

PROJECT: Twin Oaks—Painting City Curbs at or near the Intersection of MO-141 and Big Bend Road (Contractor Services Contract, August 1, 2018)
RE: Change Order #1

This memo provides documentation for a change order on the above project and Agreement.
This change order concerns changes to pay items:

Add Item – Painting Intersection of Big Bend at Highway 141: Approximately (12) Traffic Lights to receive spot priming on bare areas one coat of Sherwin-Williams Paint applied to match existing.

- Price includes all necessary lift rental
- **\$2,800 Lump Sum** – to be completed at same time as curb painting

Add Item – If required by MoDOT: Contractor’s additional traffic safety and control measures.

- This item is contingent upon additional traffic control measures being mandated by MoDOT during permitting.
- **\$1,500.00 Lump Sum**
